- b. Location : The event will take place in Sofia – Bulgaria
3. Responsible to : IWBF Europe;

4. Accommodation : for 16 members of the delegation;
5. Referees : Shall be nominated by the Technical Commission;
6. Classifiers : Shall be appointed by the Classification Commission;
7. TD/GC : Shall be appointed by the Competitions Commission;
8. Entry Form : To be **returned latest February 28<sup>th</sup> 2019** to the IWBF Europe Office together with a surety fee of 750 euro. The entry form is valid and will be accepted only after this amount is paid. **An invoice will be send after receiving of the Entry Form;**

9. Team Statement : To be **returned latest April 30<sup>th</sup> 2019 to the Competitions Commission**. We kindly ask you to fill out up to the maximum of 24 players and signed by an IWBF or national licensed classifier.
10. Competition Form : A contrasting digital colour passport picture (between 250 and 500 kb) of the players and staff members in JPG file format, need to be sent to the Competitions Commission with the Team List;
11. : The Travel Form and the Room List Form including a picture of the team are to be returned to the address of the organiser as soon as possible;

**Please note that the Competitions Forms must be returned as an electronic MS Excel file;**

12. : Registration form new players, including copy passport to be handed over to the Chairman of the Classification Panel;
13. Entry Fee per team: Entry fee : € 1.500,00  
Fee per Day : € 1.200,00
14. Referee Fee : Each team will be charged a Referee Fee of 750,00 Euro. IWBF Europe will send you a specified invoice for this amount to be paid by your NOWB. **Thus do not pay before your receive this invoice.**
